

# **Data Protection policy**

#### 1. General

Anglo-Swiss Advisors LLC is the operator of the and provider of the services offered on this website. Thus, Anglo-Swiss Advisors LLC is responsible for the collection, processing and use of your data and must ensure compliance with Swiss law. The protection of your personal data is a top priority at Anglo-Swiss Advisors LLC. Here we inform you about what data is collected on and how it is used. You will also learn how you can check the accuracy of this information and arrange for us to delete this data. Please note that this Privacy Policy may change from time to time. We therefore recommend that you regularly read this privacy policy to ensure that you are always familiar with the latest version.

## 2. Collection, use and processing of personal and company-related data

By visiting certain data is automatically stored on our servers for system administration, statistical or backup purposes. These are:

- your IP address (under certain circumstances)
- the date
- the time
- the website from which you http://www.anglo-swissadvisors.com/
- the keywords you used <a href="http://www.anglo-swissadvisors.com/">http://www.anglo-swissadvisors.com/</a>

Under certain circumstances, this data may allow conclusions to be drawn about a specific visitor. However, personal data will not be used in this context. The use of such data is exclusively anonymous.

By registering as a user and entering your data on you agree that your entered data will be used for service-related use.

Furthermore, you agree that your data may be used for advertising purposes. If you do not agree to the use of the data for advertising purposes, you can prohibit this at any time by writing to <a href="mailto:contact@anglo-swissadvisors.com">contact@anglo-swissadvisors.com</a> by e-mail.

# 3. Information, deletion and correction

You can request information about your data stored by us at any time. We ask you to send a request for information by e-mail to the address below. Together with the request, proof of identity is required at the same address.

You have the possibility to request the deletion or correction of your data at any time. Of course, you are also entitled at any time to revoke your consent to the use or processing of personal data with effect for the future. Please send us an e-mail to contact@anglo-swissadvisors.com.

Stored data will be deleted by us when it is no longer needed for the stated purpose.

With regard to the deletion of data, it should be noted that we are subject to certain legal obligations which provide for a retention obligation for certain data. We have to fulfil this obligation. If you wish the deletion of data which is subject to the statutory retention obligation, the data will be blocked in our system and only used to fulfil the statutory retention obligations. After expiry of the retention period, your request for deletion will be complied with.

## 4. Data security

We will keep your data secure and therefore take all reasonable steps to protect your data from loss, access, misuse or alteration. Our employees and contractual partners who have access to your data are contractually bound to secrecy and compliance with data protection regulations. In some cases, it will be necessary for us to pass on your requests to companies affiliated with us. Your data will also be treated confidentially in these cases.

### 5. Cookies

To facilitate the use of our website we use so-called "Cookies. "Cookies" are small pieces of information that are temporarily stored by your browser on your computer's hard drive and are necessary for the use of ours. Thus, the information contained in the cookies serves session control, in particular to improve navigation and enable a high degree of user-friendliness of a website. The cookies we use do not store any personal information. Most web browsers automatically accept cookies. You can avoid this by changing the settings of your browser. You can remove cookies stored on your PC at any time by deleting the temporary Internet files (browser bar "Tools-Internet options").

Disabling cookies may mean that you cannot use all the functions of our portal.

## 6. Plug-ins

#### 6.1. Google Analytics

This website uses Google Analytics, a web analytics service provided by Google Inc. ("Google").
